SECTION B – SCOPE OF SERVICES

1. Introduction

- 1.1 Yayasan Peneraju's Intervention Programmes are intended to provide career advancement opportunities through industry-relevant certification training. As there are several initiatives that have been implemented to address the issue, this Programme must therefore be designed to fill the gaps of existing initiatives and/or to focus on niche areas which have yet to be offered by any other agencies.
- 1.2 The objective of this Programme is to address the current shortage of Bumiputera chartered accountants by increasing the number of percentage to **30%** by year 2030. The candidates shall be qualified with any of Professional Accounting certifications awarded by Professional Bodies as follows:
- a. Association of Certified Chartered Accountants ("ACCA"); **or**
 - b. Malaysia Institute of Certified Public Accountants and Chartered Accountants Australia & New Zealand ("MICPA – CAANZ"); **or**
 - c. Institute of Chartered Accountants in England and Wales ("ICAEW"); **or**
 - d. Certified Practising Accountant ("CPA") Australia; **or**
 - e. Chartered Institute of Management Accountants ("CIMA").


2. Scope of Services

The scope of work for the RFP are as follows:

2.1 Program Requirement

To provide Peneraju Professional Accounting programmes certification for a minimum of at least one (1) as listed in Para 1.2 including the scope of services as follows:

- a. To conduct outreach, assessment and selection of the scholars;
- b. To provide the training programmes, facilities and trainers for the Professional Accounting programmes to be offered;
- c. To conduct Nurture and Development Programme ("NDP") to scholars currently undertaking Professional certification in Accounting; and
- d. To provide welfare and management programmes to the scholars.
